## REGISTRATION AND FEES:

### Who Must Attend?

Pesticide applicators with category G (Forestry), and category J (Rights-of-Way), must attend an approved continuing education class every two years.

All classes will cover categories A, G, and J.

### Do You NEED To Attend a Class In 2015?

Look at the front of your pesticide applicator license card. To the right of your company name and address you will see the categories for which you are certified and the latest date by which you NEED to recertify (take a class). If your license says, recertify by Dec 31, 2015, you NEED to attend a class in 2015

### FEES

The registration fee for this class is \$165.00
